**NARRATIVE:** This entire report is typical of Thompson's use of opinions and guesses to exonerate the suspect, Apollo Scott, and avoid establishing probable cause, at all costs, with lies, omissions, misinformation, and refusals to investigate.  
**PRIMARY**

**CASE TITLE:** Animal Cruelty / Malicious Mischief

**EVENT DESCRIPTION:** On 04/09/21 I was working as 2S76 in Whatcom County. I had received multiple voice mail messages from contact Jennifer DUBROW that morning prior to my shift reporting someone had left a dead chicken in her driveway and flattened a tire on her car.

Dubrow told me she suspected Apollo SCOTT because she had been involved in an ongoing dispute with him and his family and had filed a claim against them in small claims court. Dubrow told me Apollo had been served the previous day and she believed the tire and chicken were in retaliation for the small claims filing.

Dubrow advised she had also filed claims against [REDACTED] [REDACTED] [REDACTED] [REDACTED] and [REDACTED] [REDACTED] and their families. Dubrow told me [REDACTED] and his family had also been served. [REDACTED] and [REDACTED] had not yet been served.

Dubrow told me she believed Apollo was responsible because he had been involved in a police report having something to do with chickens in the past. (20A-32149) I reviewed the report from that incident. Apollo had been contacted at a friend's property in central county on a shots complaint. Investigation determined the friend had been shooting raccoons he claimed were attacking his chickens.

**FALSE. If he'd asked for proof I'm in a Wi-Fi dead zone, I would have provided it.**

Dubrow had previously told me she was looking into getting a security camera system so I inquired if that had been done. Dubrow told me someone had been out to her residence and determined she was in a bad wifi spot and cameras would not work. That information did not seem correct to me but when I asked further Dubrow simply stated cameras weren't an option for her.

**FALSE. I asked him to investigate when I returned. He flatly refused.**

Dubrow had already picked up the chicken and had was with her car at Discount Tire for repair when I contacted her so there was no scene to visit or investigate. Dubrow told me she had taken some pictures of the chicken and I asked her to send them to me. (See attached photos.)

**FALSE. If he'd asked for proof of where the puncture was or what caused it, I would have provided it.**

The chicken was white and appeared to me to be a Leghorn hen (or similar). The head appeared to have been crushed. The carcass was left within a couple feet of her flattened tire. The flattened tire as on the passenger side rear of the car and based on her photos appeared to be the side away from the house and toward the road. Dubrow later sent me a picture of the receipt for the tire but there was no information on where the puncture was or what may have caused it listed. The cost of the new tire was \$149.66.

On 04/13/21 I went to Dubrow's neighborhood to see if I could locate any cameras on neighboring houses that may have captured useful footage. I did not locate any.

**FALSE. Based on all the circumstantial evidence, Apollo Scott was a suspect.**

**WCSO deputies consistently refuse to interview juveniles or other viable suspects, to avoid establishing probable cause and stopping the crimes.**

At this time there are no known witnesses or suspects.
