CASE TITLE: Malicious Mischief.

EVENT DESCRIPTION: At about 0935 hours, on 09/09/2021, I was dispatched as the primary investigating deputy to contact Jennifer DUBROW regarding her tires being slashed. This is a summary of this event.

After several phone calls, I was eventually able to contact Jennifer by phone. Jennifer explained she noticed this morning her tires had been slashed and suspects Appolo SCOTT is responsible. Jennifer advised she is currently in a court proceeding with Appolo and suspects he slashed her tires in an attempt to make her not show up for the court proceedings where she is petitioning for an order against him.

Jennifer advised me she has a video of the incident but was not able to definitively say it was Scott in the video; rather, she suspects it is him. I advised her I would forward her an evidence.com link for her to upload the video at her convenience. Jennifer, it would likely be a day or two before she could upload the video due to her being in court all day today. She thanked me for my time, and I ended the call.

At this time, there is no PC to arrest Appolo for malicious mischief. Upon reviewing the security footage, I will add a supplemental report to this case.
