EVENT DESCRIPTION:

On 08-02-21, at approximately 1903 hours, I contacted Jennifer DUBROW by phone regarding a trespass complaint at her residence, 705 Sumerset Way, Sedro Woolley WA. Jennifer advised that Danielle BROCKER had come to her residence today regarding a flyer in the neighborhood that Jennifer had posted.

Jennifer advised that she has "no trespassing" signs up and has had previous issues with Jennifer and one of her roommates, Reuben SANCHEZ. Jennifer requested that they both be formally trespassed from her property.

I responded to 732 West Road, Sedro Woolley WA and made contact with both Danielle and Reuben. Both were cooperative and Danielle advised that she had gone over to Jennifer's residence on today's date to discuss the flyer that Jennifer had posted.

I was able to give Danielle a trespass warning, along with Reuben, since he was on scene. Both advised that they understood the warning. A trespass entry was made in Spillman for both Danielle and Reuben.
