AFFIDAVIT - DODD

To whom it may concern,

I have lived in the Glenhaven community for over 37 years, and I have worked for the Glenhaven Homeowners Association for 18 years. I know Apollo and Chris Gabe and Max as they live in the neighborhood where I live. I have had many run ins with these boys over the last several years and can speak to their character in my dealings with them.

Max has been caught on several neighbors' cameras ringing doorbells and running, I witnessed him throwing rocks at another neighbor's dog and watched him swear at and flip off that same neighbor for telling him not to harm their dog.

Gabe and Chris stole a neighbor's canoe last summer, took it for a joy ride then brought it into shore on the GLC "island" where they helped other kids including Apollo's younger brother Alexander sink it.

Gabe, Chris, and Apollo were caught by a community member on Reed Lake at the boat launch last year with two kayaks and a paddle boat, all belonging to community members and taken without permission. that community member reported to me that he had questioned them about several community complaints about them which included Chris and possibly Gabe participating in beating up a child on the corner of Glenhaven Drive and Rainbow Drive, witnessed by two young children, the trespassing and slashing of another neighbors Christmas blow up display, and the stealing of the neighbor's boats. At that time, they all admitted to the offences and said they would not do it again. Max was also involved in the slashing of the Christmas display.

All 4 boys along with other neighborhood kids have continually been the topic of conversation on a community neighborhood page for their rude and disrespectful behavior towards both adults and other children and for their participation in blocking and stopping cars from getting by when they are gathering on Glenhaven drive.

On New Year's Eve this year, Apollo, his brother Alexander, and a few other boys were seen shooting pellet guns off their deck and shattered the neighbors sliding door and put several holes in their other windows and the side of their house.

Gabe has been seen on four occasions driving vehicles including a full-size van and a suburban in Glenhaven. On two occasions an adult was not seen in the vehicle with him. Gabe, Chris, and Apollo have had many complaints from neighbors due to the disturbance they cause in the neighborhood riding their dirt bikes.

Apollo vandalized a backhoe owned by GLC. It was clear that a great amount of time and detail was spent in trying to cause the damage. Rocks in the hydraulics, sand and rocks in every hole or opening among other things. Apollo did community service for the association during which time Apollo and his younger brother Alexander were caught pushing GLC picnic tables into the lake.

Some neighbors report that they do not report the incidents anymore because they hear from local authorities that their "is nothing they can do" or they fear retaliation.
