NARRATIVE:

PRIMARY - Anders

CASE TITLE: Trespass / Burglary

EVENT DESCRIPTION:

On 12/13/20 at about 16:43 hours I contacted the RP, Todd MATHEWS, by phone about a burglary and kids trespassing at 5060 Sand Rd, Harmony Elementary. Todd is the school Principal.

Todd said he came to the school to check on it and while walking around he heard thumping sounds on the roof. He said he went onto the roof via the interior roof access point and located two juveniles skateboarding on the roof. Todd said he recognized one of the juveniles as a former student, [REDACTED], but he didn't recognize the other juvenile. The other juvenile was later identified as Apollo SCOTT. Todd said he told them they were not allowed on the roof and made them leave. He said they played dumb asking, "Oh we can't be here?", but they did leave.

Todd said it has been a long standing problem that the roof can be accessed via the exterior of the building so they would not have had to gain entry into the building to access the roof.

Todd said he also discovered someone had entered the school and propped open an exterior door with some Dixie cups. He said the individuals raided a janitor's closet and took paper towels and toilet paper, which they then TP'd the back of the school and school grounds.

Todd said he suspected [REDACTED] and Apollo had TP'd the grounds because the door had been propped open with the Dixie cups, but shortly after he ran [REDACTED] and Apollo off the Dixie cup door stop was also gone. Todd said he suspected they took it to cover their tracks after being confronted.

I responded to [REDACTED] house ([REDACTED]) and spoke to his mother, Deanna BYEMAN. Deanna said Alec was not home now because he and his father had just left to take Apollo home. Apollo lives in Glenhaven.

I explained to Deanna why I was there and what Todd had reported. Deanna said no doubt her son probably was on the roof and she would make sure that he was appropriately disciplined for it. I told her that [REDACTED] was trespassed from the school and if he returned he could face criminal charges for trespassing. She said she would make sure he is aware and that wouldn't be an issue in the future.

I also discussed that it was possible [REDACTED] and Apollo entered the school and then used the stolen paper towels and toilet paper to TP the grounds. Deanna said she didn't think her son would enter the school or do any damage to it, but she would discuss that with him. Deanna said she would call Apollo's parent's and let them know what happened.

After leaving Deanna's residence I called Apollo's mother, Tania SCOTT. I explained why I was calling and she said Deanna had already called her. I told Tania that Apollo was trespassed from the school and if he returned to the property he could face criminal charges. She said she understood and would relay that to Apollo.

I also explained that it was possible that [REDACTED] and Apollo entered the school and took the paper towels and toilet paper and then TP'd the grounds. Tania said she would ask Apollo about that and call me back if she learned anything.

At this time I do not have probable cause to arrest [REDACTED] or Apollo for burglary, but they have been trespassed from the property. I entered the trespasses into Spillman.
